# **CASPER and PsySTART Behavioral Health Assessments** following a Disaster

On August 24, 2014, at 3:20 a.m., a magnitude 6.0 earthquake struck California, with its epicenter in Napa County (1). The earthquake was the largest to affect the San Francisco Bay area in 25 years and caused significant damage in Napa and Solano counties, including widespread power outages, five residential fires, and damage to roadways, waterlines, and 1,600 buildings. One fifth of respondents overall (27% in Napa and 9% in western Vallejo) reported one or more traumatic psychological exposures in their households. These findings were used by Napa County Mental Health to guide immediate-term mental health resource allocations and to conduct public education campaigns to support persons with mental health risks following the earthquake. Individuals who have gambling addiction and their family members often do not have the financial resources available to get help and this network provides a funding of last resort to pay for those individuals who have no other means to pay for gambling addiction treatment.

#### **Network Membership**

Being a member of the network means that you (as a private practice clinician) or the agency you work for, can receive a limited amount of reimbursement for clients for whom you are providing treatment for gambling addiction or for affected others (who have no other means to pay for services.) Your name and contact information will also be available through 2-1-1 as a resource for those seeking gambling addiction treatment.

Save the Children Emergency Contact Card

To make planning easier, <u>Save The Children</u> has a great new resource that allows parents to create an <u>Emergency Contact Card</u> online. This card will let your child and his or her caregivers know whom to contact in the chaotic aftermath of a calamity. It even allows you to identify a non-local point of contact, so someone outside the affected area can step in if you are unreachable, and captures information about the child's allergies and medication needs.


## **About Maine's Health Care Coalitions**

The Northeastern Maine Regional Resource Center (NE-MRRC), Southern Maine Regional Resource Center (SMRRC), and the Central Maine Regional Resource Center (CMRRC) were started in February 2004, and charged with developing comprehensive plans for a coordinated healthcare response to public health emergencies within their respective regions. The RRCs continue to serve as hubs for information and resource sharing and are responsible for the evaluation of the region's current capabilities, and the development and maintenance of regional emergency responses plan for healthcare that will complement existing plans.

The RRCs are healthcare coalitions involving key partners within each regions catchment areas including hospitals, rural health clinics, federally qualified health centers, emergency medical service providers, home health agencies, nursing homes and long-term care facilities, mental health agencies, substance abuse agencies, municipal health officers, municipal health departments, tribal health departments and health centers, county emergency management agencies, local emergency planning committees, local public health districts, American Red Cross Chapters, and schools.

regional Hazard Vulnerability Analysis (HVA) and completed a Training and Exercise Planning Workshop. Members collaborated to determine the following top five hazards they felt healthcare faced in the central Maine region: Cyber Attack, Major Hazmat Incident, Ice Storm, Major Infrastructure Damage, and Heavy Snow/Blizzard. The CMHPC then used that information to help determine what training and exercises should be offered regionally and developed a tentative three-year plan. Upcoming trainings include Public Information Officer Training, Medical Preparedness and Response to Bombing Incidents, and Hospital Emergency Response Training (HERT). SMRRC has had some summer hiatus in Regional meetings but behind the

scenes pusiness ques on. This summer we have been preparing for our

September Coalition meeting, which is a combined meeting with York County Public Health District. It will include a Table Top Exercise that will focus on post Hurricane recovery, including the health issues associated with mold abatement, water contamination, debris removal and vulnerable populations. This summer we have been working on checking the inventory of hospital emergency equipment. This equipment helped hospitals in the areas of personal protective equipment, patient isolation, emergency respiratory therapy, and patient decontamination and monitoring. We are assessing items that have become obsolete due to wear and tear and age. Most equipment was purchased over 10 years ago and is at the end of it's life cycle. We have been slowly buying equipment to replace aged items. This included the purchase of new decontamination tent floors and washing basins. This will keep the capabilities of each hospitals decontamination teams up to speed. SMRRC has also been working on our statewide ebola preparedness at the 4 assessment hospitals. This included a state and federal team helping to get hospitals ready for any future ebola patients.

# **Northeastern Maine Regional Resource Center** (NE-MRRC)

The Maine Emergency Management Agency, the Federal Emergency Management Agency, and the National Transportation Safety Board are conducting a one-day large scale aviation accident response exercise scheduled on September 24, 2015 in Bangor. This exercise will feature an NTSB outreach and training session followed by a facilitated, scenario-driven tabletop exercise. The entire event will examine the ability to coordinate and deliver required capabilities across multiple jurisdictions to affected communities in the aftermath of an airplane accident.
